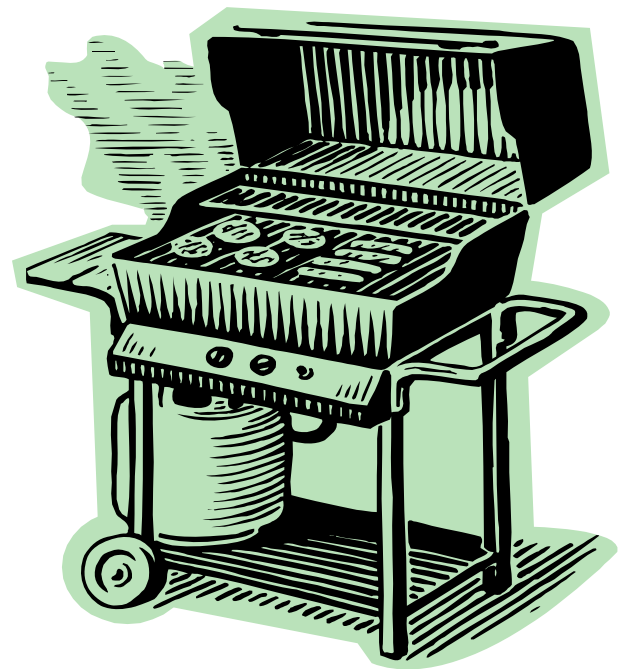
### NALS Summer Social
