1. <u>President's Report</u>. KC.

Old Business.

4.1 Spring Bash

Following motions were made and approved:

Spring bash will have a no host bar. Tickets will be \$35 per person, \$280 per table, \$20 for those making \$50,000 or less per year. The bar will pay for honorees and their presenters, but not guests, other than the Kosydar family. We won't subsidize law student tickets beyond the \$20 rate. (Natalie Scott/Deb Velure, second).

Additionally, insurance is approved for up to the cost of \$200 (Natalie Scott/Jay McAlpin, second).
