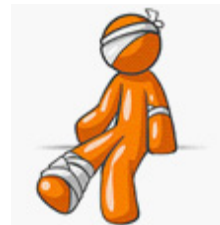

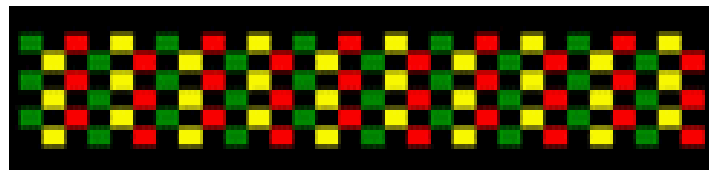
DERRICK BELL LECTURE SERIES

**Barbara R. Arnwine** will deliver the Derrick Bell Lecture at the **UO Law Knight Law Center, Room 175, on Tuesday, February 7, 2017 at 4:00 p.m.** Ms. Arnwine is president and founder of the Transformative Justice Coalition, which is internationally renowned for contributions on critical justice including the passage of the landmark Civil Rights Act of 1991 and the 2006 reauthorization of provisions of the Voting Rights Act. Ms. Arnwine is a graduate of Scripps College and Duke University School of Law. She currently teaches at Columbia Law School. She is the board vice-chair of the National Coalition to Abolish the Death Penalty and serves on the board of directors of MomsRising and Independent Sector. Arnwine’s work also includes women’s rights, immigrant rights, judicial diversity, criminal justice reform, racial profiling, health care disparities and LGBTQ rights.

The lecture series is in memory of former Dean **Derrick Bell**, who died on Oct. 5, 2011. Dean Bell is the first African-American dean in the history of the University of Oregon



School of Law and one of the first African-American law deans at a non-historically Black institution. This series recognizes the contributions Dean Bell made to academia and the pursuit of equity during his career. Dean Bell wrote extensively about race in the United States and challenged the academic institutions he served to commit to diversity. Traditionally, this lecture is held in February, which is Black History month.

Meets Chief Justice Order No. 05-028, Section 3.2 and Community Dispute Resolution Center requirements for 30-hour Basic Mediation Curriculum. Learn to apply mediation principles and practices to assist disputing parties to resolve their issues. Through lecture, video, role-play, and discussion, this instruction will help participants: gain an understanding of conflict resolution and mediation theory; effectively prepare for mediation; create a safe and comfortable environment for the mediation; facilitate effective communication between the parties and between the mediator and the parties; use techniques that help the parties solve problems and seek agreement; conduct the mediation in a fair and impartial manner; understand mediator confidentiality and ethical standards for mediator conduct adopted by Oregon and national organizations; and conclude a mediation and memorialize understandings and agreements.

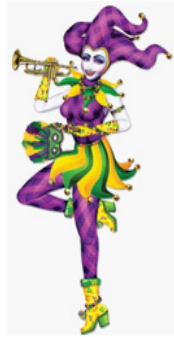
