PRACTICE TIP FROM THE BENCH

With the advent of e-filing, the initial routing of ex parte documents is the responsibility of the clerk's office rather than the attorney walking the order through 8:30 ex parte call. The clerks **need your help** in understanding where the matter you submit should be directed. UTCR 5.060(3) provides that:

"A motion for an *ex parte* order **must** contain the term '*ex parte*' in the caption and must be accompanied by a proposed order."

That designation and an accompanying order will get your motion into a judge's ex parte queue for prompt review. If no such designation is made or no proposed order is tendered Lane SLR 5.005(1) directs the clerk to put the motion on the civil motion docket in the ordinary course to be heard on the 5th succeeding Monday after the motion is filed- that is when the motion will come before a judge. If your motion requires some special handling before presentation please address the circumstances in the motion and in a cover letter to the clerk so staff can make a determination as to when the matter should be submitted to the judge for review. Remember, if you want the court to expedite or delay a hearing once it has been set you must comply with the conferring requirements of Lane SLR 5.005 (3) or the request will be summarily denied.

Your cooperation in following these rules will be greatly appreciated by the court and will help us greatly in handling your clients' cases in a more expeditious fashion. Thank you.

GUARDIAN PARTNERS NEEDS VOLUNTEER MONITORS IN LANE COUNTY.

As a volunteer monitor, you will be appointed by the Court to a specific case. Your job will be to review the file at the Probate Court, visit independently with the Guardian and the Protected Person and write a report to the Court regarding your findings.

Volunteer monitors are at the heart of our mission to ensure vulnerable Oregonians are not experiencing abuse or neglect. The information you provide to the Judge will be essential in deciding how to best proceed in an effort to ensure the Protected Person is safe and thriving.

This volunteer opportunity is a great fit for someone who needs flexibility as you can take a case at a time and work around your schedule to get the job done. If you are someone who wants to volunteer working directly within the legal and social service systems to help prevent abuse and neglect, Guardian Partners needs you.

1945 - 2016


Terry Hammons died of heart failure on December 31, 2016. He was in private practice for over 40 years, specializing in business litigation. Terry was a longtime



FOCUS ON CHILDREN & MEDIATION ORIENTATION

A required class for divorcing, divorced, and separated parents

Parties are required to register within 15 days of receiving this notice.

You are <u>required</u> by the Court to attend Focus on Children if you are the parent of a child under 18, AND you are a party in a Lane County annulment or dissolution of marriage or domestic partnership, legal separation, petition to establish custody or parenting time (including paternity), or post-judgment litigation involving custody and/or parenting time. Attendance fulfills the mandatory parent education program (Lane County Circuit Court Local Rule 8.012) and the mandatory mediation (Lane County Circuit Court Local Rule 12.001) requirements.

Focus on Children helps parents respond to their children's needs and minimize the negative impacts of divorce and separation. The class also addresses parents' rights and responsibilities, custody, parenting plans, and the family adjustments to new living arrangements. Class attendance enables parents to access free custody and parenting plan mediation at Youth Services.

SCHEDULE: Wednesday evenings, 5:30 to 8:30 p.m.

Note: Focus on Children will be held on Tuesday evenings from February 28-April 25, 2017, 5:30 to 8:30 p.m.

COST: \$60 per person. Fee waivers are granted only if a fee *waiver* from the Lane County Circuit Court was granted when you filed your paperwork with the court. Visit our website to apply.


