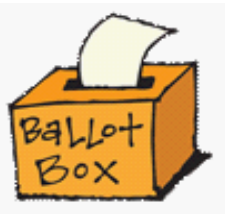


LCBA JUNE LUNCHEON

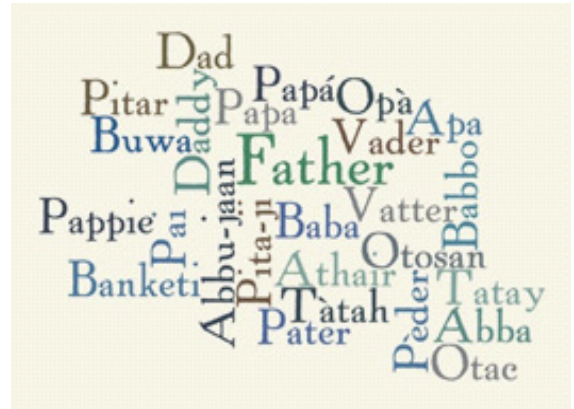
