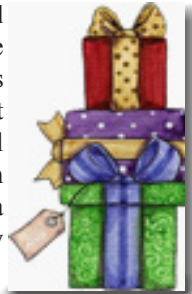
FREE DEBTOR-CREDITOR CLE

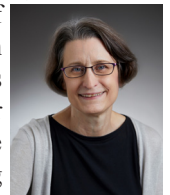

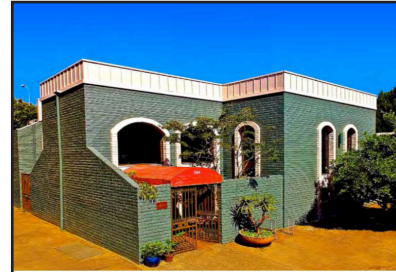


BAR NEWS SUBMISSION DEADLINE
