Shaun started practicing law with her father **Bob McCrea** in 1983. Father and daughter tried the full range of criminal cases in state and federal court throughout Oregon for 30 years, until Bob retired. In 2016 Super Lawyers named Shaun in the top 25 women lawyers in Oregon and Shaun became the Executive Director of the Oregon Criminal Defense Lawyers Association (OCDLA); the two events are not related. Shaun is a past president of OCDLA, served on the NACDL Board and as Ninth Circuit Representative to Defender Services Advisory Group (DSAG) and Criminal Justice Act (CJA) Representative for the District of Oregon. In 2018 she received the James M. Burns Award in Criminal Law from the Oregon Chapter of the Federal Bar Association. Shaun teaches trial advocacy at the University of Oregon School of Law and coaches the UO law school mock trial team.

This event is a continuation of the free CLE series from the Education Workgroup assigned by **Presiding Judge Jay McAlpin** and headed by **Judge Clara Rigmaiden**. These lectures are intended to bolster interest in indigent criminal defense, make it more accessible, and improve trial skills amongst the local bar. Watch for future sessions each month covering specific trial skills presented by local masters of their craft.



Campaign for Equal Justice Update and Luncheon Nov. 1

Happy fall everyone and welcome to another exciting campaign season. For those new to the bar, the Campaign for Equal Justice is a non-profit organization, established by Oregon attorneys back in 1991, whose mission is to make equal access to justice a reality for Oregonians. Each year, the Lane County Steering Committee, with the help of many Lane County attorneys, works to raise funds that are used to support Oregon's statewide legal aid programs. The various local bars in Oregon have a (mostly) friendly competition each year for the Justice Cup (awarded to the region with the highest percentage of lawyers giving) and the Equity Cup (awarded to the region with the greatest percentage increase in lawyer giving). The good news is that we won the Equity Cup last year and it will soon be residing under Judge McAlpin's watchful eye at the Lane County Courthouse. The bad news is that we won with only 23% attorney participation. In other words, even though most of us appreciate that we have a professional obligation to either contribute time or money to ensuring equal access to justice, only 23% of the attorneys in Lane County participated last year.

This year, we are working to increase that percentage to at least 31% and raise \$100,000, but we need your help. Please make your contributions as early as possible and encourage others to do the same. If we are able to hit these goals, we are very likely to not only retain the Equity Cup, but also bring the Justice Cup back to its rightful home in Lane County. Further, we have it on good authority that given the space constraints at the Lane County Courthouse, a new courthouse will need to be built in order to properly house these trophies. In other words, we have a lot riding on the Campaign this year.

Court Closure October 8th

Chief Justice Flynn has signed an order closing all Circuit Courts on Tuesday, 10/8/2024. The official closure tolls all statutory timelines. The closure is to accommodate an update of the court's case management system and to provide an opportunity for staff training. On 10/8, staff will report to work, but (like a weekend) the court will not be open to the public; we will not hold proceedings, accept filings, or be available for communication via phone or email. Also like a weekend, the pretrial release office will have minimal staffing and will make release decisions.

Announcements from the Oregon State Bar

Case Management Offline for Tax and Circuit Court <u>10/4-10/7</u>

The case management systems for the circuit courts and tax court will be offline from 5:00 pm Friday, October 4th to 8:00 am Monday, October 7th to allow for upgrade installation. It is highly recommended that attorneys who have hearings on October 7th, 8th or 9th submit all documents by Wednesday, October 2nd to ensure that the court has timely access. The above-mentioned courts will also limit the types of hearings scheduled on October 7th. If you have any questions regarding this matter, please contact Sam DuPree at the Oregon Judicial Department at L.S. Depree@ojd.state.or.us.

Additionally, the Oregon Judicial Department (OJD) will conduct a major update to the Odyssey Court Management System in October. To ensure a smooth transition, Chief Justice Meagan Flynn has issued <u>CJO 24-015</u>. This order **closes all OJD courts on Tuesday October 8th** and extends the statutory time limit for filings pursuant to ORS 174.120(2)(c).

THE DISTRICT

THE DISTRICT is an invaluable resource for local or out-of-town attorneys who may need a place for depositions or a temporary office while working in the Eugene/Springfiled area.

A month-to-month membership for a flex desk is \$375 per month, an annual membership has a discounted rate of \$340 per month. There is no deposit associated with a flex membership, but we do collect a one-time \$50 registration fee.



ABOUT US: OLC is a legal services program committed to achieving justice for the low-income communities of Oregon by providing a full range of the highest quality civil legal services. OLC operates eleven offices around the state. It has a litigation support unit, legislative advocacy unit, and statewide farmworker program. OLC strives to create a supportive work culture enriched by values of diversity, equity, and inclusion (DEI) for all staff. Eugene is located along the Willamette River and has a dynamic mix of arts and culture, entertainment and sports, the University of Oregon, craft brewing and eclectic dining, and cycling and track and field opportunities.

RESPONSIBILITIES: The managing attorney is responsible for creating and maintaining an excellent legal aid office as defined by our criteria for manager evaluation and program values statement. The managing attorney will handle and supervise impact litigation and individual cases, with a significant emphasis on class action lawsuits and other impact cases in state and federal courts. The managing attorney will engage in education and outreach to clients and community groups and will build positive and effective relationships with community partners. The managing attorney will promote mutual respect, acceptance, and teamwork among a diverse staff, and will challenge and inspire others to achieve positive results and grow professionally. This position offers an exciting opportunity to use leadership skills to make a real difference for the low-income communities of Oregon.

FROM THE PRESIDENT'S DESK

Dear Colleagues:

I hope this note finds you well. I suspect you are enjoying yet another colorful autumn there in Lane County. After I return from travels, I too look forward to this annual delight. Until then, thought I'd report some recent happenings at the *LCBA Board of Directors*.

PREVIOUSLY - Broad Trajectory

Recall, my prior July 2024 Bar News opening remarks alluded to my dual aims-if we can get there-to:

- Internally Engage: Rally board members around internal house cleaning (e.g. refined work committees, action-oriented collegial culture, standard operating procedures, fiscal responsibility measures, modernization)
- Externally Engage: Per efficiencies gained internally, board volunteer time can focus more on engaging you—the members we serve—with membership benefits that are: (1) professionally meaningful to you – AND- (2) in turn, mutually beneficial for your clients & our community. Here are some potential engagement points:
 - <u>Colleagues</u> (e.g. LCBA creates ways for you to get to know, like & trust those in other practice areas to entrust cases / referrals to, share other vital professional resources, develop rapport & collegiality)
 - Local (e.g. LCBA creates ways for you to network & engage with our community through speaking, pro bono & leadership opportunities.)
 - <u>Beyond</u> (e.g. A collegial local network yields natural opportunity for nomination of LCBA members to leadership positions at the state, regional & national levels, so we can celebrate our best & finest in benevolent service).

CURRENTLY - Emerging Focus

Since Summer 2024, two(2) board meetings have occurred. Both meetings focused on engaging the board with these simple prompts: (1) WHAT do we want to do -AND- (2) HOW we get there.

I am pleased to report that the one thing our board appears united about is restoring your *LCBA Sections* (formerly "Committees"). Basically, *LCBA Sections* connect members aligned by: (1) *Practice Area* (e.g. Estates) -OR- (2) *Common Cause* (e.g. Mentoring, Pro Bono). Post-COVID, very few sections remained active. Most have unfortunately gone dormant. The board is intent on changing this. In the coming months, our focus will be to prune inactive sections, restore anemic ones -AND- create new TBD sections for our members. Each section *Chair* enjoys the support of a dedicated *Board Liaison*. Ultimately, I imagine a "lean & mean" set of truly active *LCBA Sections* to simply make things happen to get people connected. We aim to restore *LCBA Sections* so that they once again sparkle as bastions of *External Engagement*, in whatever modern form they may take ahead.
